As an approved farmers' market, the Cochrane Farmers' Market must qualify for the 80% vendor rule. That means, the Alberta product must be grown, produced, handcrafted, processed, or baked by you or an immediate family member or staff. The Alberta Approved Farmers' Markets allow only 20% of sales to come from out of province and/or resellers.

Market Stalls: I require ___ stall(s).

I prefer: 6m wide x 3 m deep (north side) - vendor works from side of vehicle
OR 3m wide x 8m deep space (south side) - vendor works from back of vehicle

The Cochrane Farmers' Market will allocate stalls as they see fit to provide a good market mix. Full-time vendors will be given priority in space assignments

The Cochrane Farmers' Market and the Alberta Farmers' Market Association are providing you the right to sell at the Cochrane Ranche Historical Site under permit. You do not require a separate permit from the Town of Cochrane. Please note that full-time vendors will be given priority in space assignments and the Cochrane Farmers' Market reserves the right to assign spaces and select vendors that meet the market criteria.

As a vendor:

- I understand that I am responsible for my own display materials (chair, tables, awning, etc.) Cochrane Farmers' Market cannot supply running water or electrical hook-ups.
- I understand that in respect for the customers and fellow vendors, I will maintain regular attendance and will not dismantle or vacate my space until 1:00 p.m. or Cochrane Farmers' Market has the right to resell the remaining days in my contract and I forfeit my vendor fee.
- I will leave the space provided to me free of garbage. I will not use the public garbage receptacles at the Cochrane Ranche to dispose of any commercial waste.
- I understand that if I sell food products, it is my responsibility to contact the Public Health Inspector prior to coming to the market to ensure compliance with the Inspector's standards, applicable regulations and safe food practices. Cochrane Farmers' Market does not refund vendor fees if the Health Inspector does not allow you to sell a product.
- In order to comply with the Personal Information Protection Act, I give consent to the Cochrane Farmers' Market to disclose my Name, Company Name and/or telephone number to those persons inquiring about my product(s).
